New data available on the massive diversion of State, Local and Federal funds to charters, approved and proposed

**Reimagine Prep Charter School** in **south Jackson** has already been approved for the 2015-2016 school year. The contract awaits.

The applications for **Inspire Charter School** in **Columbus** and **Midtown Charter School** in **midtown Jackson** *are pending*, with the decisions on these two applications to be decided at the December 5, 2014 meeting of the MS Charter School Authorizer Board.

Under Mississippi law each approved charter school becomes its own new separate school district, distinct from and without any duty toward or responsibility for its impact on any other school district. But the diversion of operations funding from our traditional public schools to new charters will have great impact.

Here is the data from the **Reimagine, Midtown** and **Inspire** *applications* that document that more than \$38 million will be diverted from the Jackson and Columbus school districts over the 5 years from the 2015-2016 school year through the 2019-2020 school year.

NOTE: In each of these 3 applications the projected diversion of State, Local and Federal funds amounts to more than \$9,000 per student per year during the 5-year period of the first contract.

Whether these 3 charters [i.e. 3 new school districts], if approved, turn out to be good schools is a separate question from the impact that this massive diversion of funds will have on the Jackson and Columbus districts ... which are already seriously under-funded because the Legislature fails and refuses to fully fund MAEP!

In 2014 the Legislature passed an **MAEP** funding bill [FY 2015] in which Jackson and Columbus were *underfunded* by these amounts:

Jackson: \$14,864,586 underfunded Columbus: \$2,302,927 underfunded Total: \$17,167,513 underfunded

And now these districts can look forward to the possibility of the strangling vise of systemic underfunding combined with the diversion of under-funds to new charters. This is *not* a plan for the success of our traditional public schools.
